

# Norwalk Police Activity Report

## 11-13-15

**DISCLAIMER: All defendants are innocent until proven guilty in a court of law.**

11-05-15: Traffic Stop – 900 block Sunset Drive – Joshua Rattray, of Norwalk, was arrested and charged with Driving while revoked, Failure to prove security against liability and Operating a non-registered vehicle. Subject was cited to appear at a later date.
