

ORDINANCE NO 18-01

**AN ORDINANCE PROVIDING FOR SPEED LIMITS ON NORTH AVENUE
EXTENDING FROM
HIGHWAY 28 WEST TO THE CITY LIMITS, SUPPLEMENTING CHAPTER 63.**

Be It and It is Hereby Ordained by the City Council of the City of Norwalk, Iowa:

Section 1. Purpose. The purpose of this ordinance is to supplement Chapter 63.04 Norwalk Code by establishing special speed zones for North Avenue extending from Highway 28 westerly to the city limits.

Section 2. Special Speed Restriction. Based on the type of road, location and use, the Council has determined it is in the best interest of the City of Norwalk and its citizens to establish special speed zones as follows.

Section 3. North Avenue 35 Miles Per Hour Speed Zone. The following shall be added to Chapter 63.04(1) Norwalk Code as a new subparagraph "G" of Special 35 MPH Speed Zones:

G. On North Avenue extending from the center of Highway 28 westerly 6,150 feet. Between the hours of Seven o'clock (7:00) am and Seven o'clock (7:00) pm, Monday through Friday, the speed limit within the school district located on North Avenue, as marked, is twenty-five (25) miles per hour.

Section 3. North Avenue 45 Miles Per Hour Speed Zone. The following shall be added to Chapter 63.04(2) Norwalk Code as a new subparagraph "I" of Special 45 MPH Speed Zones:

I. On North Avenue extending from the west edge of the thirty-five (35) miles per hour zone westerly to the City limits.

Section 4. Repealer. Any ordinance or parts of ordinances in conflict with the provision of this ordinance are hereby repealed.

Section 5. When Effective. This ordinance shall be in full force and effect upon passage and publication as provided by law.
