ORDINANCE NO 18-04

AN ORDINANCE ADOPTING THE EXISTING CITY CODE OF THE CITY OF NORWALK, IOWA, 2010, AS THE CODE OF ORDINANCES OF THE CITY OF NORWALK, IOWA, 2018

BE IT ORDAINED by the City Council of the City of Norwalk, Iowa, as follows:

SECTION 1. PURPOSE The purpose of this ordinance is to comply with the provisions of Section 380.8, Code of Iowa, requiring cities to compile a code of ordinances at least once every five years.

SECTION 2. CODE ADOPTED. The CODE OF ORDINANCES OF THE CITY OF NORWALK, IOWA, 2010, as amended by Ordinances No. 17-01 through 17-23, both inclusive, being found to be correct and adequate for the City is hereby readopted as the CODE OF ORDINANCES OF THE CITY OF NORWALK, IOWA, 2017, with the following amendments:

- A.** Title. Section 1.01 is repealed and the following enacted in lieu thereof;
1.01 TITLE This Code of Ordinances shall be known and may be cited as the Code of Ordinances of the City of Norwalk, Iowa, 2018.
- B.** DEFINITIONS. Section 1.02, subsection 5 is repealed and the following is enacted in lieu thereof;
 - 5. Code of Ordinances means the Code of Ordinances of the City of Norwalk, 2018.

SECTION 3. AMENDMENTS. All general ordinances of the City passed hereafter shall be in the form of an addition, amendment or repealer to the CODE OF ORDINANCES OF THE CITY OF NORWALK, IOWA, 2018, and shall include proper references to title, chapter, and section or subsection to maintain the orderly codification of ordinances.

SECTION 4. COPY ON FILE. An official copy of the CODE OF ORDINANCES OF THE CITY OF NORWALK, IOWA, 2018, adopted by this ordinance, including a certificate of the City Clerk as to its adoption and the effective date, is on file in the office of the City Clerk and is available for public inspection.

SECTION 5. EFFECTIVE DATE. This ordinance shall be in full force and effect from and after its publication, as required by law.
