The contractor and owner hereby expressly release and discharge and agree to hold harmless, defend and indemnify the city, its elected officials, officers, agents and employees from any and all duties, responsibilities, obligations, claims, demands, causes of action or liabilities arising out of or any way related to the issuance of this permit or any inspection performed or certification issued in connection with this permit.
