

**ORDINANCE NO. 19-06**

**AN ORDINANCE ADOPTING THE NORWALK, IOWA, MUNICIPAL CODE, 2019**

**BE IT AND IT IS HEREBY ORDAINED BY THE CITY COUNCIL OF THE CITY OF NORWALK, IOWA:**

- Section 1. Purpose.** The purpose of this ordinance is to comply with Section 380.8 of the Code of Iowa and amendments thereto relative to the adoption of the Norwalk, Iowa, Municipal Code.
- Section 2. Adoption.** The said Norwalk, Iowa, Municipal Code, 2019 be adopted in its entirety, and that grade ordinances, bond ordinances, zoning map ordinances, ordinances vacating streets and alleys, and ordinances containing legal descriptions of urban revitalization areas and urban renewal areas shall remain effective and be in full force and effect.
- Section 3. Content.** The Norwalk, Iowa, Municipal Code, 2019 is composed of all City ordinances presently in effect except grade ordinances, bond ordinances, zoning map ordinances, ordinances vacating streets and alleys, and ordinances containing legal descriptions of urban revitalization areas and urban renewal areas. This Code of Ordinances contains only existing ordinances previously adopted by the City Council without change in substance.
- Section 4. Official Copy.** An official copy of the Norwalk, Iowa, Municipal Code, 2019 as adopted, including a certification by the Clerk of the City of Norwalk, Iowa, as to its adoption and effective date shall be on file at the office of the City Clerk. Copies of the official copy of the Norwalk, Iowa, Municipal Code, 2019 shall be kept available at the office of the City Clerk of the City of Norwalk, Iowa, for public inspection.
- Section 5. Repealer.** All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.
- Section 6. Severability Clause.** If any section or provision of parts of this ordinance or the Norwalk, Iowa, Municipal Code, 2019 be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of this ordinance in whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.
- Section 7. When Effective.** This ordinance shall be in full force and effect upon publication, as required by law.
