YOU ARE REQUIRED BY LAW TO ANNUALLY LICENSE ALL DOGS SIX (6) MONTHS OR OLDER. LICENSES ARE DUE BY MARCH 31. ON APRIL 1, A \$10 PER DOG LATE FEE WILL APPLY.
*New residents and/or new pets are not subject to late fee but must license within 30 days.
In accordance with City Code a household may have no more than three (3) dogs over the age of six (6) months.

By checking this box, the applicant acknowledges and represents to the City that all dogs listed in the licenses application have obtained a current rabies vaccination, pursuant to the City Code of Norwalk. Any false statement to the City in this regard may result in animal license revocation and possible criminal enforcement.

<p>ANIMALS DEEMED VICIOUS City code(s) requires owners of dogs deemed vicious must license their dog and provide proof of liability insurance for bodily injury in the amount of \$TBD when licensing the dog. You must notify this agency at least ten (10) days in advance of cancelling or terminating the policy.</p> <p>What you will need to submit:</p> <ul style="list-style-type: none"> - Proof of Rabies Vaccination - Proof of spay or neutering if you are licensing a pet at the altered rate for the first time. This is often indicated on the animal's rabies vaccination certificate. <p>SERVICE ANIMALS Certified service animals are subject to licensing requirements and fees.</p>	<p>Please Note. The license tags you will receive are permanent tags designed to last many years. The number on the tag is your dog's permanent identifier. If you need a replacement tag please call City Hall at 515.981.0228.</p> <p>Tips for filling out your dog license application. Residents that take advantage of Norwalk's online utility bill pay option, XPressBillPay.com, may renew their dog's license online each year. License applications that are submitted without the correct information and payment amount will be returned and will have to be resubmitted. Please check your completed application carefully before submitting in order to avoid penalties due to delays. If you need another application, please go to www.norwalk.iowa.gov and download another form. Forms will also be available in a number of locations and veterinarian clinics throughout the city.</p>
